# Huge Victory for Right to Counsel in NYC!

On February 12th, the Mayor and the Speaker announced that they are committed to passing legislation mandating universal access to legal representation for low-income tenants in housing court! When it passes, this will mean that tenants no longer have to fear unjust evictions, will no longer have to fear eviction as retaliation for organizing in their buildings or holding their landlords accountable, and will mean that we have more tools to fight gentrification. This is a victory for all of New York!

February's landmark agreement sends a strong message to tenants that our lives, homes and communities matter, that the City won't stand by as they are forced to navigate the courts without representation and that they will be protected. This is a huge step forward towards creating a more equitable and just city.

This announcement is also a testament to the power, strength and beauty of organizing and would not have been possible without the visionary leadership and steadfast organizing of tenants in the Bronx and across the city!

# Bronx Residents Put on Pressure at Jerome Ave Rezoning Town Hall



Almost 300 Bronx tenants, workers and community members questioned City Council Members Vanessa Gibson and Fernando Cabrera at <del>a</del> the March 2nd Town Hall on their positions in relation to the Bronx Coalition for a Community Vision demands for a just rezoning on Jerome Avenue.

The two Council Members were

asked about their support for specific demands in the Coalition's alternative plan and whether or not they would push back the start date for the ULURP process if the City's plan does not meet our needs.

At the Town Hall, Coalition members confirmed support for key anti-displacement policies

such as Right to Counsel, the newly introduced bill to create a Certificate of No Harassment, and the creation of an HPD Task Force on displacement, along with support for worker safety legislation, an acknowledgement of the need for truly affordable housing and the need for a plan for the auto industry. Yet we know this is not enough!

We still need to keep the pressure on the City and the Council Members to make sure the plan they vote on is a plan that works for our Bronx!

# **Building Highlights**

### Tenants at 1970-72 Walton Ramp Up Pressure

1970-72 Walton tenants are making a statement that they are ready to fight! After organizing a tenants' association, sending a letter to management, calling 311 together, and meeting with management, tenants are ramping up the pressure to take their management company to court for lack of repairs and services.



### 955 Walton Build on MCI Opposition

After initially uniting to oppose their landlord's MCI, tenants at 955 Walton have built power through a series of tactics including sending letters to the landlord, filing a DHCR Rent Reduction application, and meeting with the management company directly, and now they're ready to take their organizing to the next level!

### 750 Grand Concourse Takes Action in a Crisis

After an ongoing rat infestation led to a public health crisis in February, tenants organized quickly to demand accountability in a heated forum with HRA head Steve Banks, Public Advocate Letitia James, and local elected officials. Due to the work of the tenant association, HPD is working closely with the tenants and landlord (named NYC's #4 Worst Landlord in 2017) to ensure tenants will receive building-wide essential repairs and rent-stabilized protection for 50 years.

# New Settlement Community Builds Post-election Power

In the first 100 days of Trump's administration, CASA joined with Urban Youth Colthe larger New Settlement Apart- laborative and the ments community including the Parent Action Committee, Community Food Action and the College Access Center to organize a resource fair and community conversation about our rights and the steps we can take to build power in our communities.

On February 23rd, we organized our first convening where we discussed how our struggles are connected and that we can come together to fight for our neighbors. We had guest presenters from the Arab American Association of New York (AAANY). Families for Freedom (F4F).
